This is an MoU between “PK Agro-Industrial Products (M) Sdn. Bhd.”, having its address at Lot 4, Lingkar Sultan Hishamuddin, Kaw 20, Selat Klang Utara, 42000 Port Klang, Selangor, hereinafter called PKA and Faculty of Natural Resources, Prince of Songkla University, having its address at 15 Karnjanavanich Rd., Hat Yai, Songkhla 90110, Thailand which for the purpose of this MoU is represented by its Faculty of Agriculture, hereinafter called FNR-PSU.

#### **I. PURPOSE & SCOPE**

This Memorandum of Understanding (“the MoU”) forms the basis of a voluntarily participation and intention between PKA & FNR-PSU to establish internship opportunities and educational opportunities for students studying in FNR-PSU (the Internship). This MoU defines and formalises the relationship between the parties in an internship arrangement with FNR-PSU.

The MoU is independent of any other agreements signed by or between the organisations concerned.

#### **II. GENERAL**

An internship is a cooperative student program between PKA and FNR-PSU. PKA will provide supervision, facilities and instruction that help the student of FNR-PSU to acquire skills and knowledge related to their chosen field of study or occupation.

Neither PKA nor FNR-PSU will be responsible nor held liable for any claims, disputes, losses, damages, injuries, adverse events or outcome arising out of or caused only by the other party’s act, omissions or negligence.

#### **III. IT IS MUTUALLY UNDERSTOOD AND AGREED BY AND BETWEEN THE PARTIES THAT:**

- Both parties have expressed interest for the internship arrangement.

- It shall be the responsibility of each student to comply with PKA's policies and procedures, all national and local law, rules regulations, ordinances and codes applicable to PKA.
- PKA shall assist to apply for the Immigration Visa for the Students to stay in Malaysia during the internship period.

#### IV. FINANCIAL ARRANGEMENTS

Each Party will be responsible for its own costs and expenses in establishing and conducting the internship arrangement contemplated under this MoU. KPA will provide free lodging and meals for students during the Internship Program

#### V. EFFECTIVE DATE AND SIGNATURE

This MOU shall be effective upon the signature of PKA and PSU authorized officials. It shall be in force from 1<sup>st</sup> July 2023 to 31<sup>st</sup> May 2028 for a period of **five (5) years**, unless sooner terminated, revoked or modified by mutual written agreement between the parties, and may be extended by mutual written agreement. Either party may terminate this MoU at any time during the term of this MoU by the provision of three (3) months advance written notice to the other party.
